2B Secure 4.2 Data Privacy Software Completed

An overview of the most important new features: The documentation of the data processing in the order has been expanded considerably. Data processors can now be saved locally for a process or centrally for the entire application. The inclusion of hierarchical levels of procedures will allow the user to, in the future, assign individual procedures to other procedures at another level.

For extended protection of web-based training, 2B Secure 4.2 will use HTTPS to communicate with the training platform. The permitted file extensions can now be determined in order to avoid that problematic files are processed via 2B Secure. In environments where this concern is a reality, the files can then be restricted to permitted file types. In addition, users who have made adjustments to the various "dropdown lists" (deciding on goals, procedural statuses, etc.) will be able to select which of these should be updated and which should be left as they are.

Saving time and money allows for the function of transferring authorizations and tasks when replacing personnel. The same applies for the copy function used for measures. It allows the predefinition of prototypical measures and the reutilization of existing measures in other areas. By dispensing with technical role names, 2B Secure 4.2 is also becoming easier to use.

Company license users will receive the 2B Secure 4.2 on a CD that will be sent by mail. The CD will include installation notes. All other license holders will receive Secure 4.2 by e-mail and a download link.
