Presentation of 2B Secure 4.5 Data Privacy Software

2B Advice, an international consulting company based in Bonn that specializes in data privacy, today rolled out version 4.5 of its 2B Secure data privacy software. The functions of the web-based training courses and the online audits and the options for the documentation of technical/organizational measures have been considerably extended.

Video and audio files can now be incorporated into the web-based training courses (WBTs). While the content of the WBTs has long been freely extendable, the style can now also be fully adjusted in line with the customer's corporate design. For the sake of simplification, any element of your choice can be referenced when creating a training course, so that content has to be maintained in just one location, even if it is used more than once. "Tens of thousands of company employees have already been trained and tested with the WBT module. We have been overwhelmed by the feedback and have therefore considerably extended the functionality", says Hans Joachim Bickenbach, Managing Director and Sales Manager of 2B Advice.

An online audit can now be monitored with 2B Secure 4.5, which offers overviews for the available online audit templates, the prepared audits and their status. Like the WBTs, the audit web pages are now fully adjustable in line with the content and corporate design of the user.

The technical/organizational measures (TOMs) can now be documented and managed directly in the process, and a specimen catalogue is available. Furthermore, an audit can be generated directly from the TOMs and adherence to the measures can be checked. Two new reports are available – one to confirm adherence to one's own TOMs and one to confirm adherence to the TOMs by a commissioned data processor.

Version 4.5 of 2B Secure is rounded off with options for procedure documentation and procedure reporting, a function to remind the user about measures and other improvements.
